IMPORTANT DETAILS:

— **INDIVIDUAL REGISTRATION:** Unlike our individual leagues (offered in the spring, summer and fall), there are **no limits on player and roster requests**. You can **register an individual** or **enter a full team**. Participants at the high school level cannot currently be rostered on a high school team.

— **TEAM REGISTRATION:** A full team must consist of a minimum of eight (8) players, and a coach must be provided by the team.

— Team rosters and game schedules will be posted by **noon Tuesday, Nov. 7, 2017**, on the Hoosier Hills Hoops website (www.hoosierhillshoops.com). **It is your responsibility to check for league information; you will not receive a phone call or email!**

— Participants are guaranteed a minimum of seven games and each Sunday will play two games. League play will end on the final day (Dec. 10, 2017) with a single-elimination tournament.

— Participants will receive a T-shirt that must be worn as game jersey for all league contests.

— Our leagues will be used as a proving ground for players to receive invitations and further competitive basketball opportunities, including the **Team Southern Indiana** and **Club Hoosier Hills** AAU programs.

Amateur Athletic Waiver and Release of Liability and Assumption of Risk Agreement

Read before signing.

In consideration of being allowed to participate in any way in the Hoosier Hills Hoops 2017 Winter Recreational Basketball League Session I, related events and activities, I, the undersigned, acknowledge and agree that:

1. I am fully aware that the risks and hazards connected with the activities in this program are significant, including the potential for permanent paralysis and death; and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. Participation is voluntary. By allowing my child/dependent to participate in the Hoosier Hills Hoops 2017 Winter Recreational Basketball League Session I, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for their participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any hazard during my presence or participation, I will remove my child/dependent from participation and bring such to the attention of the nearest Hoosier Hills Hoops official immediately; and,

I, for myself and on behalf of my child/dependent, heirs, assigns, personal representatives and next of kin, HEREBY AGREE TO INDEMNIFY, RELEASE AND HOLD HARMLESS Hoosier Hills Hoops LLC, Clarksville Community Schools, their officers, officials, agents and/or employees, other participants, sponsoring agencies, advertisers, and, if applicable, owners and lessors of the premises used to conduct the event ("Releasees") with respect to any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss or damage, including INJURY, DISABILITY AND DEATH or loss or damage to a person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE to the full extent allowed by law.
5. It is my express intent that the agreements and promises made herein shall bind the members of my family, my spouse and my heirs, assigns and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE the above-named RELEASEES.

PERMISSION FOR THE USE OF IMAGES: I give permission for my images or the images of my child that are captured through video, photo or digital camera to be used for Hoosier Hills Hoops' purposes, including promotional material and publications, and waive any rights of compensation or ownership thereto.
